EARLY CHILDHOOD SERVICE DIVISION: THE EARLY CHILDHOOD SERVICES (ECS) PROGRAM SERVES OVER 465 CHILDREN AGES SIX WEEKS TO PRE-KINDERGARTEN AT THREE SITES. PLAY-CENTERED EDUCATION IS FULL OF WEEKLY ACTIVITIES, INCLUDING SINGING, DANCING, READING, COOKING, AND CREATIVE ARTS, AS WELL AS MASTERING PRE-K SKILLS. THE CHILDREN ALSO LEARN TRADITIONAL JEWISH VALUES THROUGH JEWISH PROGRAMMING, SUCH AS NEARLY 18,000 HOURS OF JEWISH AND HEBREW EDUCATION, AND CELEBRATING 697,680 HOURS OF JEWISH HOLIDAYS, TRADITIONS, AND HISTORY WITH PARENTS, GRANDPARENTS, AND SIBLINGS. JCC PRESCHOOLS TYPICALLY GRADUATE OVER 125 STUDENTS ANNUALLY, WHO MOVE ON TO KINDERGARTEN. 75% OF THE GRADUATES CONTINUE TO JEWISH LEARNING OPPORTUNITIES, INCLUDING DAY SCHOOLS, RELIGIOUS SCHOOLS, HEBREW SCHOOL,

PROGRAMS INCLUDE AN ACA ACCREDITED SUMMER DAY CAMP FOR OVER 600 CAMPERS AT TWO SITES, A STATE LICENSED LATCHKEY PROGRAM REGULARLY SERVING OVER 75 STUDENTS PER WEEK, AND SCHOOL'S OUT/ VACATION DAY PROGRAMS SERVING 25-50 STUDENTS PER DAY.
